

Familiarization programmes for Independent Directors

Introduction:

Familiarization Process:

- 1. Such programmes provide an opportunity to the Independent Directors to interact with the senior leadership team of the team.
- 2. The programmes also include familiarization on statutory compliances as a Board Member including their roles, rights and responsibilities.
- 3. At the Board Meetings the Independent Directors are apprised of risk management process and its outcome, Company policies, changes in regulatory environment as applicable to the Company and Industry, quarterly presentations on operations made to the Board includes information on business performance, operations, market share, financial parameters, working capital management, fund flows, senior management changes, major litigation, compliances, subsidiary information, etc.
- 4. The Company also circulates news and articles related to the industry from time to time and specific regulatory updates.
